

BUSINESS SCHOLARSHIPS



What types of scholarships are available at the W. P. Carey School of Business?

- General Scholarships -- These scholarships are available to any business student meeting the stated scholarship criteria. The Scholarship Selection Committee and/or the donor select the recipient for each of these scholarships.
- Departmental Scholarships -- The academic units within the W. P. Carey School of Business offer these scholarships/awards. These are restricted to students majoring in a particular discipline.

Who can apply?

All undergraduate business students are encouraged to apply.

How do I apply?

All students should apply through the W. P. Carey School of Business General Scholarship Application which is available online in November at:

<http://wpcarey.asu.edu/scholarships>.

The General Scholarship Application is used to determine award eligibility for the majority of scholarships offered through the school of business including departments. Scholarships are awarded based on varying "scholarship criteria," including GPA, leadership and community service, major, class level, financial need, and residency classification. Scholarship awards range from \$500-\$10,000.

The W. P. Carey School of Business General Scholarship Application is an online application which will be available early November 2016. In addition, the application should be completed every academic year. Scholarships are awarded for the **2017--2018** academic year unless otherwise stated.

- **The application is online and must be submitted electronically.**
- Upload a copy of your resume detailing internships, work experiences, educational accomplishments and leadership positions.
- Complete required essays.

When is the deadline date?

The deadline date for **current/transfer students is Tuesday, January 17, 2017.**

How will I know if I receive a scholarship?

All students will be notified by May. Most business scholarships will be awarded by that time. You are responsible for notifying the school of business scholarship office of any address changes, including temporary summer addresses.

When will my funds be disbursed?

Disbursement of business scholarships for the academic year begins on or about the first week of classes for the Fall semester. Please refer to the Financial Assistance web site for disbursement information at: <http://students.asu.edu/financialaid/apply>.
