## havasupai promise scholarship



# what is the havasupai promise scholarship?

The Arizona Board of Regents (ABOR) has established the Havasupai Promise Scholarship program. This program is open to eligible Havasupai tribal members who have been admitted as full-time, degree-seeking students at an ABOR university (Arizona State University, Northern Arizona University and the University of Arizona). Eligible Havasupai tribal members include all currently enrolled members of the Havasupai Tribe and their enrolled children from family households as well as the children of the individual plaintiffs who were parties to the March 2010 settlement agreement with ABOR.

The Havasupai Promise Scholarship program covers admitted undergraduate recipients for full-time enrollment for five consecutive academic years (fall and spring) and admitted graduate recipients for full-time enrollment for three consecutive academic years (fall and spring). This scholarship program will provide a total of 30 undergraduate scholarships (with a maximum of four new awards per year across the three ABOR universities) and a total of five graduate scholarships.

#### what the program covers

Educational costs covered by the program include tuition, mandatory fees and standard allowances for room and board, plus books and supplies. These items are estimated "direct costs." Estimated direct costs represent the true cost of attendance at the universities. Additional "indirect (personal) costs," such as transportation, parking decals, loan fees and other personal expenses, are not covered by the program. #### eligibility requirements

Eligible Havasupai students are required to apply for other non-loan financial aid offered by the university, federal and state agencies. Financial support from these sources will make up a part of the Havasupai Promise Scholarship. Accordingly, students must complete the Free Application for Federal Student Aid (FAFSA, available at fafsa.gov) to be eligible for the Havasupai Promise Scholarship program. The FAFSA will be used to calculate the expected family contribution (EFC).

#### all deadlines for financial aid must be met

Financial documents, necessary for verification purposes, will need to be submitted to the appropriate university financial aid office by the required deadlines; for specific information on university financial aid deadlines, please contact the appropriate university contact indicated in this brochure.

#### renewal

In addition to meeting admission requirements, Havasupai Promise Scholarship recipients must meet eligibility renewal requirements for continued enrollment and continued scholarship support in subsequent years. Students must maintain good standing per the academic requirements of the student's university and degree program.

# how does the program work?

- 1. A budget of your estimated direct cost of attendance is created. This includes:
  - A. Actual tuition and mandatory fees.
  - B. Standardized allowance for housing and meals.
  - C. Standardized allowance for books and supplies.

Your estimated cost of attendance is determined in accordance with federal regulations. Each university develops its own standardized allowances and applies them consistently to all students.

- 2. The university will take your expected family contribution (EFC), as determined by your FAFSA, and subtract it from your estimated direct costs. Your EFC will appear on your Student Aid Report. Federal law requires the university to take into account a student's EFC.
- 3. The remaining estimated direct costs are then covered by a combination of gift aid from federal, state, private and institutional sources. The gift aid will be a combination of scholarships and grants (e.g., Pell Grants, Federal Supplemental Educational Opportunity Grant, Leveraging Educational Assistance Partnership Grants, institutional grants and scholarships).
- 4. Your total cost of attendance includes indirect costs, such as transportation and personal items. However, these items are not covered under the program.



### sample costs
